Acceptance of goods covered by this invoice constitutes agreement to pay collection and attorney's fees actually incurred if this account is not paid in full by the due date.

Past due invoices are subject to a 1.5% finance charge.

Insufficient fund checks will be charged a \$35 service fee.

Return Policy

All returns must have prior "Return Material Authorization".

All returns must be new, in original un–opened box – if not in this condition, they will be subject to 20% restocking fee or "make new" fee.

Special order/Custom Parts may not be returned for credit except under warranty.

Used items may not be returned for credit.

Change Order or Delivery Date Changes

Any customer requested changes to accepted P.O.s (including scheduled delivery dates) may result in the P.O. being re–negotiated.

Export
